- b. Revise Mission and Vision
 - **Mission Statement:** The Maryland School Counselor Association (MSCA) advocates for and promotes excellence in the profession of school counseling to support current and future school counselors in fostering the full potential of all students' academic, career, and social/emotional development across all regions of the state.

MSCA, in association with the American School Counselor Association (ASCA), empowers all Maryland school counselors to promote every aspect of student success through implementation of the National Model.
- 5. Treasurer's Report X. Medina
 - a. \$30, 946.34 in account as of June 1, 2019
 - b. Biggest jump is \$26,517.28 in membership dues (843 members/747 are individual professionals) About 31% of the counselors in MD.
 - c. Goal to get membership closer to 50% of the state.
 - d. Need to confirm prices with Xiomara first so that she is able to code everything properly. (no way to differentiate when two things are the same price). *Would be best if everything was a different price.
 - e. Need to fill in the OFF months for the Multiview Marketing on the website
 - f. Need to increase our accounting budget to cover annual fee (Needs to be at \$2,250 next year).
 - g. Keep in mind that LDI is in Seattle in 2020 & will most likely cost more.
 - h. Moving Networking funds to Prof. Dev. (will keep some for social events).
 - i. Membership: Wild Apricot has increased cost but they still have everything we need and is currently the best option. Also need to consider the cost of membership packet.
 - j. Gala (no-shows) Working on invoicing members and removing registration if not paid.
 - k. We did not budget for Box but never got rid of it. Need to figure out where it is going to go. **TO DO:** Create an email address for each position.
