

 - a. Career Ladder: Due to definition of "teacher," school counselors are not included

- Even though School Counselors can achieve NBCT, we are being excluded from the career ladder due to statute that pre-existed the Blueprint
 - 1. Will be meeting with state legislator to make a formal request that they make an inquiry with the Attorney General to determine whether SC qualify as "teachers." That outcome will determine next steps
- ii. Working with State Delegates
 - 1. Goal is to have a Legislative Day in Annapolis so that SC can meet face-to-face with legislators (educate about our role, share impact of laws on our day-to-day reality).
- iii. Working on identifying members to serve on state work groups
 - Workgroup on Black, Latino, Asian American, Pacific Islander, and Other Underrepresented Behavioral Health Professionals-develop recommendations on how to increase representation.
